TUITION PAYMENT POLICY 2012 – 2013 SCHOOL YEAR

REGISTRATION:

- A \$100.00 *non-refundable* fee per family is due at the time of registration.
- A parent or guardian *must* sign the tuition payment agreement on the registration form in order for your child's registration to be complete.

PAYMENT OPTIONS:

- Lock in 2011 Tuition Rate. Tuition for the school year may be paid in one lump sum, due by **March 1, 2012**. Those who pay in full will receive a \$100.00 per family discount.
- Annual Payment. Tuition for the school year may be paid in one lump sum, due by **June 1, 2012**. Those who pay in full will receive a \$100.00 per family discount.
- Monthly Payments. For your convenience, the annual tuition is divided into ten (10) monthly payments. These payments are due by the 1st of each month, beginning **June 1, 2012**, with the last payment due on **March 1, 2013**.
 - If paying monthly, you will receive a coupon book. One coupon should be enclosed with each payment. All payments should be mailed to the address listed in the coupon book
- Late Payments. Payments received after the 10th of each month are considered late. A \$15.00 late fee will be assessed on *any* payments received after the 10th of the month.
 - If you are unable to make your monthly payment on time, please contact Lynne Miner, Director immediately to discuss payment options. If your account becomes sixty (60) days past due, your child will be subject to withdrawal until the past due amount has been paid.

DISCOUNTS

- When two or more children from the same family are enrolled at Steeple School, a 10% reduction will be applied to the lesser tuition bill.

RETURNED CHECKS

- A \$15.00 charge will be assessed for any check that is returned to Steeple School by the bank.

WITHDRAWAL

- The June tuition payment is *non-refundable*.
- If, during the course of the year, it becomes necessary to withdraw your child from Steeple School, two (2) weeks written notice is required. A withdrawal form is provided in the back of your coupon book. Any refunds due will be applied within ten (10) business days of receiving the withdrawal notice.
